12.4 Approve Actuarial Study of Retiree Health Liabilities Under GASB 74/75

GASB 74/75 compliance requires districts to perform an actuarial valuation to measure and disclose the retiree healthcare liabilities for the financial statements. Districts are required to complete a full actuarial every two years. It also requires an update or "Roll-Forward" valuation annually. The Gold Oak Union School District currently contracts with Total Compensation Systems Inc. (TCS) to prepare these actuarial valuations. This report is for the fiscal year ending June 30, 2023.

RECOMMENDATION:

The Superintendent recommends the Board of Trustees approve the Actuarial Study of Retiree Health Liabilities Under GASB 74/75
